Item 1

Nor any drop to drink : the forgotten story of the noble experiment of fifty years of prohibition in Prince Edward Island / by C.R. McQuaid. - [Charlottetown], 1992. - 122p.

Prohibition of the sale and consumption of intoxicating beverages was a way of life in Prince Edward Island from the adoption by the province in 1893 of the federal legislation known as the Scott Act until the passing of the Temperance Act in 1948.

Justice McQuaid's paper covers the sale and consumption of alcoholic beverages on Prince Edward Island from the earliest days of the colony until 1990. It concentrates on the period following the passing of the first comprehensive provincial Prohibition Act in 1900 to the plebiscite of June 1948. The latter endorsed the newly passed Temperance Act which allowed individuals to purchase a restricted quantity of liquor. Justice McQuaid deals at length with the statutes themselves, the various intervening proposed amendments and plebiscites, and the political climate surrounding these events, in particular the election of 1927. He also discusses the various methods of enforcement attempted including the Prohibition Commission, the short-lived Provincial Police Force, and the R.C.M.P.

Item 2

Twice hanged and quartered : a miscellany of murder and other tales of the macabre / by C.R. McQuaid. - [Charlottetown], 1994. - 145p.

This paper relates twelve cases in the courts of Prince Edward Island for the crimes of murder or other offences for which the penalty was death. The commission of the crime, subsequent trial, and the consequence has been reconstructed from newspapers as well as from the original court records.

Item 3

Her Majesty's Counsel: learned in the law / by C.R. McQuaid. - [Charlottetown], May 1995. - [24]p.

Justice McQuaid's paper outlines the history and controversy surrounding the appointments to the rank of Queen's Counsel on Prince Edward Island from the first appointment in 1847 to the current trend towards eliminating the rank itself.

This volume outlines the judicial careers of the first nine Chief Justices of Prince Edward Island from 1770 to 1874. These Justices were John Duport, Peter Stewart, Thomas Cochrane, Robert Thorpe, Caesar Colclough, Thomas Tremlett, Samuel George William Archibald, Edward James Jarvis, and Robert Hodgson.
